Chronology :

In 2014, two aerial water way trollies were identified to have permanent deformation. The design was re evaluated and a design change was created. KME staff created a TSB on 9-28-16 and submitted that TSB to NHTSA on 9-29-16 for review. NHTSA staff contacted KME on 10-14-16 to review the submitted TSB. KME staff reviewed the TSB internally and submitted the 573 on 10-19-16.

Description of Remedy :

Description of Remedy Program : KME will install re-enforcement inserts to the side clamps of the water way trolley. KME will provide parts and labor compensation. There will be no cost to the customer.

How Remedy Component Differs from Recalled Component : The remedy component consists of a change in the pad configuration to a re-enforcement insert.

Identify How/When Recall Condition was Corrected in Production : After the design re-evaluation in 2014 a running change was made in production.
