Description of the Defect : Affected vehicles have airbag and/or pretensioner igniter(s) manufactured by Autoliv. The affected igniter(s) may not meet manufacturing specifications. In a crash where airbag and/or pretensioner deployment is needed, an igniter may not deploy, increasing the risk of injury.

FMVSS 1 : NR

Description of the Safety Risk : In a crash where airbag and/or pretensioner deployment is needed, an igniter may not deploy, increasing the risk of injury.

Description of the Cause : Autoliv has reported that the affected igniters may not actually ignite properly and fail to ignite the propellant. According to Autoliv this was caused by an improper mixture of the chemicals for the ignition of the first stage inside the igniter.

**Chronology :**

On December 06, 2016 Autoliv informed Audi AG and Volkswagen AG of their intent to file a 573 report regarding igniters on December 8, 2016, however without specific information (i.e. serial numbers of affected airbag modules).

On December 20, 2016, Audi AG and Volkswagen AG received datasets for affected components from Autoliv. On December 21, 2016, the matter was presented to Audi AG and Volkswagen AG Product Safety Committees. During the meeting Autoliv advised that serial number lists provided may not be accurate and are subject to review. Updated lists are expected to be provided by Autoliv to Audi AG and Volkswagen AG on January 06, 2017. However, based on the facts presented to the Audi AG and Volkswagen AG Product Safety Committees, a determination of defect was made.

Date of Determination: December 21, 2016

On February 17, 2017 Autoliv informed Volkswagen AG of additional vehicles impacted by this recall. Based upon this information, the Volkswagen AG Product Safety Committee made a defect determination and will recall these additional vehicles. Date of determination for additional vehicles: February 17, 2017.

## Description of Remedy :

Description of Remedy Program :	Affected airbags/pretensioners will be replaced with properly manufactured parts.
How Remedy Component Differs from Recalled Component :	Autoliv reported to have corrected the issue with the igniter chemicals in their production.
Identify How/When Recall Condition was Corrected in Production :	Autoliv reported to have corrected the issue by September 21, 2016 in their production; however this does not reflect the Audi AG or Volkswagen AG vehicle production dates. Affected vehicles will be identified by module serial numbers after Autoliv has provided them to Audi AG and Volkswagen AG.
