Description of the Defect : The MORryde ramp door design includes a Hinge Assembly at each outside bottom corner of the ramp door. According to MORryde, the puddle weld securing the hinge pin to the hinge plate may be insufficient.

FMVSS 1 : NR

Description of the Safety Risk : Based on documentation received from MORryde, if the puddle weld is not sufficiently welded, the hinge pin may separate from the hinge plate, leading the side of the door to shift. This condition could cause the springs to lift off the hinged end of the door and could cause the top of the door to swing down with more force than normal, increasing the risk of personal injury.

Chronology :

On December 15, 2016, a representative from MORryde verbally informed Forest River's – Office of Corporate Compliance of service bulletin the company was issuing concerning a welding issue with its ramp doors.

Forest River sought confirmation from the supplier of whether and where the affected ramp doors were used in Forest River vehicles and Forest River conducted an investigation of its own production records to confirm the use of the part. On December 16, Forest River's Corporate Committee reviewed the issue and decided to conduct a recall if it could be confirmed that the company used the part. On December 23, 2016, Forest River was able to confirm that the affected part had been used in certain Forest River vehicles.
