Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2011-2017 Keystone Bullet and Passport Travel Trailers. As a result, Keystone RV is conducting a safety recall.

***Reason for  
this recall***

It has been decided that the vehicles in this recall population may have wiring at the air conditioner that was not installed according to the air conditioner manufacturer's instructions. If the thermostat wires short together, there is an increased risk of damage or fire to the unit. The vehicles included in the recall range have been expanded:
