Subject: **Safety Recall 0416J - 2010-2011 Tribute V6 Fuel Delivery Module Leak**

On October 26, 2016, Mazda Motor Corporation decided to conduct a Voluntary Safety Recall Campaign to address a concern with 2010-2011 Tribute vehicles equipped with V6 engine.

Concern Outline:

The Fuel Delivery Module (FDM) may develop a crack in the vertical portion of the fuel supply port that could result in a fuel leak.

Affected Vehicles:

Customer Notification:

Mazda will notify approximately 905 customers on January 31, 2018 to bring their vehicle to the nearest Mazda dealership for repairs as parts are now available for this recall.

Important Safety Notice: The National Traffic and Motor Vehicle Safety Act prohibits the delivery of any subject vehicle without performing the necessary repair for defects or failures. Failure to perform applicable recalls before delivery can result in extensive dealer fines and penalties from the Federal Government. Therefore, you must complete this recall for all affected vehicles in your inventory prior to delivery.
