IMPORTANT SAFETY RECALL

Brake Indicator Lamp

Dear [Name],

This interim notification is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that certain [2003 through 2006 model year Dodge Sprinter] vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 105 – HYDRAULIC AND ELECTRONIC BRAKE SYSTEMS.

It is extremely important to take steps now to repair your vehicle to ensure the safety of you and your passengers.

WHY DOES MY VEHICLE NEED REPAIRS?

The brake indicator lamp on your vehicle may not illuminate during the lamp function check when the ignition switch key is turned to the on (run) position. Therefore the driver may be unaware if the brake indicator lamp is not working. If the brake indicator lamp fails, the driver will not be notified in a low brake fluid situation, increasing the risk of a crash.

This is non-compliant with regulatory requirements because the brake lamp is required to illuminate briefly when the ignition switch key is turned to the on (run) position.

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE

The permanent remedy for this condition is not currently available. We are making every effort to finalize a remedy and obtain parts as quickly as possible, and will service your vehicle free of charge (parts and labor).

FCA US will contact you again, by mail, with a follow-up recall notice when the remedy and/or parts are available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep, Dodge or RAM dealer right away to schedule a service appointment ^[2]. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit www.fcarecallreimbursement.com to submit your reimbursement request online^[3]. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.

We apologize for any inconvenience, but are sincerely concerned about your safety. Thank you for your attention to this important matter.
