



IMPORTANT SAFETY RECALL NOTICE 16V-431

Dear Dealer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Gulf Stream Coach, Inc. has decided that a defect which relates to motor vehicle safety exists in the Federal ID label installed on your trailer may have the incorrect size tire and wheel size listed on certain model 2016-2017 Ameri-lite and Super-Lite trailers.

Problem Description:

The originally installed Federal Identification Label may show the incorrect tire size as being a ST205/75D-14-C tire with a 14 X 5.5" wheel size. The correct label for the Optional Knobby Tires should read 235/75R-15-C with a 15 X 6" wheel.

Consequence:

If relying on the label, an incorrect replacement tire and wheel combination may be installed, possibly increasing the risk of crash.

Remedy:

A replacement label is enclosed to replace the original label. To install, make sure the original label is removed from the vehicle, the area where the original label was installed should be clean and dry to promote adequate adhesion of the new replacement label. Remove the label backer exposing the adhesive backed label and put in place with applied pressure. If you have concerns with being able to properly install the new label, your dealer may be contacted for assistance. Installation by your dealer will be done free of charge and should take approximately ten minutes to perform the replacement. Once label is installed, please return the enclosed postage paid card to complete this process.

What if you no longer own the travel trailer?

If you no longer own the travel trailer identified above as being part of this Recall, Please forward the new owner information to Gulf Stream Coach, Inc. at P.O. Box 1005 Nappanee, Indiana 46550 by completing the enclosed postage paid card so that the Gulf Stream Coach can contact the new owner and provide the replacement label.

Dear Dealer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Gulf Stream Coach, Inc. has decided that a defect which relates to motor vehicle safety exists in the Federal ID label installed on your Model Year 2017 Model 5210 B Touring Cruiser may have incorrect information regarding the Recreational Vehicle Data Sheet, (Certification Weight label) which does not contain the correct Front and Rear Gross Axle Weight Rating (GAWR) and Gross Vehicle Weight Rating (GVWR) for the Ford E350 Chassis built on.

Problem Description:

The originally installed Federal Identification Label may show the incorrect Front and Rear Gross Axle Weight Rating (GAWR) and Gross Vehicle Weight Rating (GVWR) for the E 350 Ford Chassis.

Consequence:

An overloaded vehicle leads to an increase risk of axle failure, property damage and or/ vehicle crash.

Remedy:

A replacement label is enclosed to replace the original label which is located inside the kitchen overhead cabinet. To install, make sure the original label is removed from the vehicle, the area where the original label was installed should be clean and dry to promote adequate adhesion of the new replacement label. Remove the label backer exposing the adhesive backed label and put in place with applied pressure. If you have concerns with being able to properly install the new label, your dealer may be contacted for assistance. Installation by your dealer will be done free of charge and should take approximately ten minutes to perform the replacement. Once label is installed, please return the enclosed postage paid card to complete this process.

What if you no longer own the 2017 B touring Cruiser?

If you no longer own the 2017 B Touring Cruiser identified above as being part of this Recall, please forward the new owner information to Gulf Stream Coach, Inc. at P.O.
