Baby Trend, Inc. (Baby Trend) has decided that certain Hybrid 3-in-1 LX booster seats fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 213, "Child Restraint Systems." The affected child seats have a center adjuster rivet that may pull through or break in the event of a crash if the harness is being used with a child weighing more than 40 lbs., increasing the risk of injury to the child. Because we stand by our number one priority of safety, Baby Trend is recalling the child seats listed in the chart below.
