

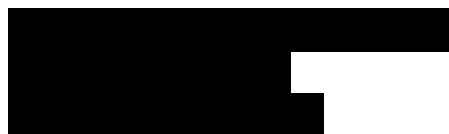


IMPORTANT SAFETY RECALL
NHTSA Recall No. 16V014

Dear Supreme Bus Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Supreme Corporation has decided that a defect which relates to motor vehicle safety exists in certain model year 2008 through 2015 Azure Hybrid, Candidate, Senator, Senator HD, Senator 2, President, President S2, Sentinel Van, Trolley and Activity buses equipped with certain Ricon wheelchair lifts. Our records indicate that your vehicle(s) identified above may be affected. Supreme is conducting a safety recall to address this condition.

What is the Issue?

Certain Supreme shuttle buses were equipped with Ricon Corporation S-Series Wheelchair Lifts that are subject to Ricon Recall No. 15E068. According to Ricon, the holes in some of the folding link arms (PN 30863) were manufactured oversized. If left unchecked, bearings can move out of position, which may allow a substantial amount of free play in a stowed platform. This free play allows for an increased load being applied to the platform mounting and can cause it to fail, increasing the risk of personal injury.

What Should You Do?

Please contact your local Ricon dealer to arrange for inspection and (if necessary) repair, which involves replacement components that have the correct size holes. This work will be done at no
