This notice applies to your vehicle(s) with the VIN(s) indicated on the enclosed owner response cards.

Dear Autocar Truck Owner:

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Autocar, LLC has decided that a defect which relates to motor vehicle safety exists in 2013-2016 model year Xpeditor chassis with dual-drive, right-hand-stand-up cab configuration. These chassis were manufactured between 15 August 2012 and 05 January 2016, with non-sequential serial numbers in the range 215038 through 222149. Our records indicate that your vehicle was manufactured within this time period and may contain the defect described herein.

MODELS AFFECTED: Autocar Xpeditor 2013-2016

COMPONENTS AFFECTED: Brake Pedal Locking Cotter Pin

SAFETY DEFECTS AND POTENTIAL RISKS: If the locking cotter pin is not engaged, the clevis pin that holds the brake pedal to its mounting bracket could come out, resulting in a loosening or detachment of the brake pedal, making it difficult to apply the service brake and possibly leading to a loss of control and increasing the risk of a crash.

REPAIR REQUIRED: Replace an existing spacer with a thinner spacer and install a new locking cotter pin.

TIME REQUIRED FOR THE REPAIR: The labor time to repair your vehicle is 1.0 hours

WHAT YOU SHOULD DO: To have your vehicle repaired, contact your local authorized Autocar service site or email warranty@autocartruck.com.

PRIOR REPAIRS: If you have previously paid for repairs relating to this recall you may be entitled to recover the amount you paid for those repairs. Submit a copy of all documentation supporting your claim to Autocar at the address set forth below in the "Assistance" section.
