IMPORTANT SAFETY RECALL
This Notice Applies To Your Recreational Vehicle VIN #
NHTSA Recall Campaign # 16V115

Dear Valued Customer:

This notice is sent to you in accordance of the National Traffic and Motor Vehicle Safety Act.

Highland Ridge RV (Highland) on **behalf of OPEN RANGE** has decided that a defect that relates to motor vehicle safety exists in certain Model Year 2012-2014 Mesa Ridge, Roamer and Light Fifth Wheels, and Mesa Ridge, Roamer, and Light Travel trailers manufactured March 23, 2011 through March 20, 2014. The information downloaded into the production system to calculate the Gross Vehicle Weight Rating (GVWR), Gross Axle Weight Rating (GAWR) and Occupant and Cargo Carrying Capacity (CCC) was incorrect and generated incorrect information on the label/s placed on units. This error may allow overloading of the trailer, exceeding the Gross Vehicle Weight Rating. Overloading of tires may lead to tire failure, increasing the risk of a crash.

The remedy for all units is to place corrected labels on the unit noting the correct GVWR, GAWR and CCC.

The correct labels for your trailer are enclosed with this Recall Notification Letter. You may place the correct labels on your trailer by following the enclosed instructions. If you prefer, you can contact a Highland Dealer to set an appointment to place the labels on your trailer at no charge to you. The placement of the omitted labels will take approximately 15 minutes. For more information or if you are unable to have this recall remedy performed within a reasonable time frame, please contact Highland Customer Service at 260-768-7771 for assistance.

If you choose to take your vehicle to a non-Highland dealer, they must contact Highland prior to making the recall repairs for proper authorization and instruction. Federal regulations require that any vehicle lessor receiving this notice must forward a copy of this notice to the lessee within **ten days**.

If, however, you take your recreational vehicle to your dealer on the agreed service date and the dealer does not remedy this condition on that date or within three (3) days, please contact our Customer Service Department at 260-768-7771. If after contacting your dealer and Customer Service you are not able to have the safety defect remedied without charge and/or within a reasonable time, you may wish to submit a written complaint to the Administrator, national Highway Traffic Safety Administration, 1200 New Jersey Avenue, SE., Washington, DC 20590; or call the toll-free Vehicle Safety Hotline at 1-888-327-4236 (TTY: 1-800-424-9153): or go to <http://www.safercar.gov>.
