NHTSA Recall 16V-178

IMPORTANT SAFETY RECALL

This notice applies to your vehicle: 9999999999999999

Dear JOHN Q SAMPLE:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

What is the reason for this notice?

Honda has decided that certain 2004 - 2007 model year Accord vehicles fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 208; Occupant Crash Protection. An incorrect passenger frontal airbag module may have been installed in your vehicle. The incorrect airbag module does not comply with airbag requirements that came into effect for the 2003 model year and may increase the risk of injury in the event of a crash.

What should you do?

Call any authorized Honda dealer and make an appointment to have your vehicle's passenger frontal airbag module inspected and, if necessary, replaced **at no cost to you.**

If your vehicle is currently under recall for the Takata passenger inflator, this repair will satisfy that recall as well.

Once you make an appointment for your vehicle, be advised that the complete inspection and repair time may take approximately 36 minutes; however, please ask your dealer for the specific time your vehicle will need to be at the dealership.

What to do if you feel this notice is in error:

Registration records indicate that you are the current owner or lessee of a 2004 – 2007 Honda Accord involved in this recall. If this is not the case, or the name/address information is not correct, please complete and sign the Information Change Card and return it in the enclosed postage-paid envelope. We will then update our records.

Lessor Information:

Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within 10 days.
