IMPORTANT SAFETY RECALL

Subject: Detroit Axle Sway Bar Mounting

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Daimler Trucks North America LLC, on behalf of its wholly owned subsidiary, Detroit Diesel Corporation, has decided that a defect which relates to motor vehicle safety exists on specific Freightliner Custom Chassis motorhome chassis manufactured March 10, 2015, through January 14, 2016, with certain Detroit front axles.

On certain vehicles, the front sway bar mounting bracket may not fit flush on the axle mounting surface, causing the mounting bolts to bend or loosen. Loose mounting fasteners could cause the sway bar to detach, resulting in higher than expected vehicle sway or reduced handling, increasing the possibility of a crash.

The sway bar mounting will be modified on affected vehicles.

Please contact an authorized Detroit Axle repair facility to arrange to have the Recall performed and to ensure that parts are available. To locate an authorized Detroit Axle repair facility, search online at www.detroitdiesel.com/locations/default.aspx. The Recall will take approximately 4.6 hours and will be performed at no charge to you.

You may be liable for any progressive damage that results from your failure to complete the Recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days. If you have paid to have this recall condition corrected prior to this notice, you may be eligible to receive reimbursement. Please see the reverse side of this notice for details.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already **paid** to have this recall condition corrected you may be eligible to receive reimbursement.

Requests for reimbursement may include parts and labor. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Detroit Diesel Corporation location. The following documentation must be presented for consideration for reimbursement.

Please provide original or clear copies of all receipts, invoices, and repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) or Engine Serial Number of the vehicle that was repaired.
- What problem occurred, what repair was done, when the repair was done.
- Who repaired the vehicle.
- The total cost of the repair expense that is being claimed.
- Proof of payment for the repair (such as the front and back of a cancelled check or

a credit card receipt). Reimbursement will be made by check from your Daimler Trucks North America LLC dealer.
