This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Crossroads RV (Crossroads) has decided that a defect which relates to motor vehicle safety exists in certain model year 2016 and 2017 Hill Country and Sunset Trail Travel Trailers. As a result, Crossroads is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

***Reason for
this recall***

It has been decided under certain circumstances the inside range burners may be extinguished unintentionally due to air movement when the outside kitchen compartment door is open. If the range burner flame is extinguished, continued propane flow in the presence of an ignition source, could result in a fire and/or explosion causing property damage and/or personal injury.

***What we
will do***

Crossroads representatives have been in contact with staff at your selling dealership regarding this situation. The remedy is to install a piece of trim board to cover the opening. The service and parts required for this corrective action will be provided at no charge to you.

***What we need
you to do***

As soon as possible, please make an appointment to have your RV serviced by your dealership. The labor time to perform this correction is approximately 1/2 hour. Please ask your dealer if you wish to know how much additional time will be needed to schedule and process your RV for this repair.

***If you have
questions***

Your dealer is best equipped to obtain parts and provide service to ensure your RV is corrected as promptly as possible. Please contact Crossroads RV Warranty/Service Department if your dealer is unable to assist or if you take your RV to your dealer on the agreed service date, and the dealer does not remedy the condition within a reasonable amount of time, or without charge to you. You may be eligible to receive reimbursement if you paid to have the defect resolved prior to receiving this correspondence. Crossroads RV Warranty/Service Department is available toll-free at 1 855-226-7496.
