This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that incorrect screws might have been used for re-securing the seat belt mount and/or the seat belt reel by Porsche dealer technicians, if they have had performed any labor operations which required the removal of the affected bolts, such as when removing and re-installing the vehicle seats. Our records show that you are the owner of a vehicle affected by this action.

What is the issue?

Porsche has determined that in the original parts catalog for the 918 Spyder model, the screws to be used for securing the seat belt mount and seat belt reel, respectively, were displayed incorrectly. The screws for each application are not the same, but in the original electronic parts catalog they had been transposed. These screws are one-time-use only and, once removed, the screws used to secure the seat belt mount and seat belt reel must be replaced.

Due to the incorrect transposition of these two screws in the parts catalog, Porsche cannot rule out the possibility that, if any service was performed which required removing the bolts, replacement bolts might have been installed in the incorrect locations. Were that the case, they may not withstand the same forces in a crash as originally intended.

What will we do?

Porsche is conducting a safety recall on these vehicles. All affected vehicles will be inspected, and if necessary, the bolts used to secure the seat belt mount and seat belt reel will be replaced with new bolts.

What should you do?

Please make contact with your authorized Porsche dealership to schedule a repair appointment and to arrange in advance for a Porsche loaner vehicle should you require alternate transportation during the repair period. Inspection and repair are expected to take approximately a half an hour.
