**Subject: Safety Recall 97CB – Side Marker Lights
Certain 2015-2017 Model Year Audi Vehicles**

Dear Audi Owner,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Audi has decided that a defect, which relates to motor vehicle safety, exists in certain 2015-2017 model year Audi vehicles. Our records show that you are the owner of a vehicle affected by this action.

What is the issue? Certain vehicles may not comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) 108 – Lamps, Reflective Devices.

In a situation where the parking lights are switched on and the vehicle is locked, the side marker lights do not illuminate, which is contrary to the requirements of the standard. This could reduce vehicle visibility, which could increase the risk of a crash causing injury and/or damage to property.

What will we do? To help correct this non-compliance, your authorized Audi dealer will correct the vehicle parameters with a software update. This work will take about an hour to complete and will be performed for you free of charge.

What should you do? Please contact your authorized Audi dealer without delay to schedule this recall repair. For your convenience, you can also visit www.audiusa.com and click on the “Find a Dealer” link to locate a dealer near you and schedule this service.

Lease vehicles and address changes If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten (10) days of receipt. If you have changed your address or sold the vehicle, please fill out the enclosed prepaid Owner Reply card and mail it to us so we can update our records.
