NHTSA Safety Recall 16V-719

THIS NOTICE APPLIES TO YOUR VEHICLE

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Our records indicate that you have purchased a vehicle with the serial number which appears above.

### REASON FOR THIS RECALL

Winnebago Industries has discovered certain travel trailers and 5<sup>th</sup> wheel trailers fail to comply with the requirements of 49 CFR, Part 56, Certification. A noncompliance exists in whereby the affected vehicles were produced with a certification/weight label displaying incorrect information in that the water weight was displayed by capacity rather than weight. Incorrect loading of the vehicle or exceeding the weight rating of the vehicle can result in possible loss of control and injury.

Should you be unable to install the new Vehicle Certification labels yourself, please contact an authorized Winnebago dealer immediately to schedule a service appointment for installation of the label. The labor time to install the label will be approximately 10 minutes. Please allow time for the dealer schedule and processing of the vehicle.

Winnebago Industries Inc. dealers are best equipped to obtain parts and provide service to ensure your vehicle is corrected as promptly as possible. HOWEVER, if you take your vehicle to the dealer on the agreed date and he does not service this condition on that date or within five days, we recommend contact Winnebago Industries Owner Relations department at 574-825-5250 x 5220.
