Dear Autocar Truck Owner:

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Autocar, LLC has decided that a defect which relates to motor vehicle safety exists in 2013-2017 model year Xpeditor chassis. These chassis were manufactured between 10 December 2012 and 1 November 2016, with non-sequential serial numbers in the range 215371 through 223684. Our records indicate that your vehicle was manufactured within this time period and may contain the defect described herein.

AFFECTED:

Autocar Xpeditor 2013-2017

COMPONENTS
AFFECTED:

Ignition relay in the back of cab fuse box.

SAFETY DEFECTS
AND POTENTIAL
RISKS:

The ignition relay coil can open due to vibration of fuse box. If the ignition relay coil opens, the engine may stall and fail to restart, increasing the risk of a crash.

REPAIR
REQUIRED:

An additional bracket will be installed to lower vibration to the fuse box.

TIME REQUIRED
FOR THE REPAIR:

The labor time to repair your vehicle is 1.0 hours.

WHAT YOU
SHOULD DO:

To have your vehicle repaired, contact your local authorized Autocar service site or email warranty@autocartruck.com.

PRIOR REPAIRS:

If you have previously paid for repairs relating to this recall you may be entitled to recover the amount you paid for those repairs. Submit a copy of all documentation supporting your claim to Autocar at the address set forth below in the "Assistance" section.
