Recreational Vehicle Safety Recall Notice

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2016 and 2017 Model Year KZRV vehicles. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to his recall were trailers manufactured with defective hinge assemblies on the rear cargo door. The weld on the hinge assembly had been ground down during manufacturing to insure clearance when installed on a door. The grinding of the weld weakened the joint. If the door were to be opened and the hinge assembly failed, the door could come down with more force than normal. The door assembly could hit a person standing near the door and cause personal injury.

What we will do

The remedy is to install hinge braces over the back of the existing hinges to secure the hinge and mounting bracket. This defect will be corrected at no expense to you, the owner. The repair should take approximately 60 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle. If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
