

IMPORTANT SAFETY RECALL – Remedy Available

This notice applies to your motorcycle,

Recall Campaign No. 16V-948: Rear Suspension Bolts

February 2017

Dear BMW Owner / Lessee:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. BMW AG has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2016-2017 BMW S 1000 RR and S 1000 R motorcycles. Our records indicate that you are the owner of a potentially affected motorcycle.

Why are we contacting you?

This recall involves either the bolt connecting the rear suspension deflection lever to the link strut, or to the rear wheel swing arm, but not both. It may not have been tightened to specifications and could become loose. We are pleased to inform you that we have the necessary parts to complete this recall. If you have not already had this recall performed, then please contact your authorized BMW Motorcycle dealer immediately to your n/ rest schedule an appointment. What could happen?

If the bolt becomes loose, it could affect handling of the mol cyc , increasing the risk of a crash.

If you hear a knocking noise coming from the carbuspension, your motorcycle may be experiencing this issue. If this occurs, carefully move away om to fic and pull over to a safe location as soon as possible. Contact BMW Motorcycle Roadside Assistants at 1877-680-2176 to have your motorcycle brought to the nearest authorized BMW motorcycle dealer. If you are not the only rider of this motorcycle, please advise important information. all other riders and passengers to the

What will BMW do?

The affected bolt will be repla ed_____tened to specifications free of charge, and will take approximately one hour.

What if the current may orc le wnership information is incorrect?

You can update motorcycle wnership and contact information by filling out the enclosed postage-paid card. If you are a motorcy ssor, Federal Regulations require you to forward this notice to your lessee within ten days.
