



URGENT SAFETY RECALL

CALL YOUR FORD DEALER NOW TO SCHEDULE YOUR FREE REPAIR



Your vehicle's seat belt buckles may be damaged increasing the risk of injury in a crash.

WHY DOES MY NEED A REPAIR?

The seat belt buckles in all rear positions are susceptible to damage if a heavy object directly impacts the top of the buckle. If the rear seatbelt buckles are damaged, the buckle cover may interfere with the normal function of the buckle, which may prevent the buckle tongue from becoming latched or potentially remaining latched. Until this safety recall is completed, passengers should verify that the rear belt buckles are not damaged and functioning properly before each use.

It is extremely important to take steps now to repair your vehicle, to ensure your and your passenger's safety!

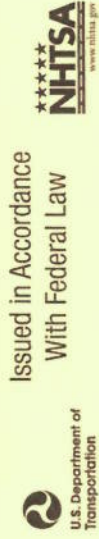

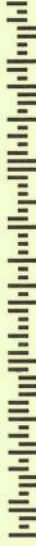
