Dear Supreme Truck Body Owner:

This second notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Supreme Corporation has decided that a defect which relates to motor vehicle safety exists in certain model year 2011-2014 Supreme Signature Van, Iner-City, and Kold King truck bodies equipped with Truck-Lite Model 21 marker lights mounted on composite plastic corner caps. We are contacting you again because it appears your vehicle has not yet been remedied under the terms of our previous recall notice. Our records indicate that your vehicle(s) identified above may be affected. Supreme is conducting a safety recall to address this condition.

**What is the Issue?**

Certain Supreme truck bodies were equipped with Truck-Lite Model 21 marker lights. Because the marker lights on these truck bodies are mounted on composite corner caps, if an electrical short occurs in the light and the light overheats, the corner cap could ignite.

**What Should You Do?**

Please contact the dealer you purchased this vehicle from or one of the service centers listed to arrange for inspection and (if necessary) repair, which involves installation of an in-line fuse and a warning decal. This work will be done at no charge (parts and labor) to you. If you have any
