# CALL YOUR LINCOLN DEALER TODAY TO SCHEDULE YOUR FREE REPAIR



Your vehicle does not conform to the requirements for child tether anchorage.

### **WHY DOES MY MY LINCOLN NEED A REPAIR?**

The left rear seat was assembled with an incorrect backrest cover, which conceals the child tether anchorage for the center seating position. This does not conform to the requirements specified by FMVSS 225 regarding child tether anchorage for the second row center seating position or child tether anchorage accessibility.

**It is extremely important to take steps now to repair your vehicle, to ensure your and your passenger's safety!**
