Dear Jaguar and Land Rover Parts Managers,

In case you missed the March 10 Retailer Webinar please find attached parts information related to the subject Recall, which will officially be released later this week.

Today and tomorrow, Parts Operations is releasing kits of airbags and associated hardware to all Jaguar & Land Rover USA retailers. Retailers in Zone A (The hot & humid States as designated by NHTSA) will all receive 12 airbags and hardware. All other retailers in Zones B & C will receive 6 airbags and hardware. These actions are being taken so that all retailers will have parts on-hand when these recalls are launched. Please look out for these shipments this week.

When the recalls are activated later this week their associated part numbers will "Go live" in the parts systems for ordering. Please place future orders responsibly for these parts. Parts should only be ordered for J069 and P081 active vehicles, and should not be stockpiled to help maintain parts availability for all retailers. There is a second phase to this campaign that will address other models and MY's, and subsequent campaigns will be launched over the course of the next year to address all vehicles over time. It is very important that retailers only place parts orders for what they need to repair the vehicles only involved in the active phases of these campaigns. # Jaguar J069 | Land Rover P081 Passenger Air Bag Recall Parts Supply & Returns of Used Parts to Takata



## **PARTS SUPPLY:**

- Repair part numbers are established for each brand.
- On March 13 & 14 JLR will make initial deployments of kits of airbags, nuts and bolts to all retailers to have parts on hand at Recall launch.
- Parts will be eligible to order at Recall launch.
- Future retailer parts orders for these parts should only be placed to address J069 & P081 vehicles.
- Campaign parts will not be eligible for JLR parts returns or Buybacks to deter hoarding.

\* LR Bolts are packaged in quantities of 25 pieces. Parts orders should be placed in increments of 25, ex. Order 25 to get one bag of 25 pieces.

## **USED PARTS RETURNS TO TAKATA:**

- Used / replaced airbags must be shipped to Takata thru XPO Logistics who are coordinating these returns.
- New / replacement parts packages should be reused to make replaced parts returns. New parts will contain parts return labels for return parts. Full return instructions to be provided in Campaign materials.
- Retailers will need to build used parts pallets and contact XPO logistics for used part pick-ups.
- Retailers must be Hazmat certified to make these returns – reference Parts Alerts JA16PA-12 (Jaguar) and PA16GI-14 (Land Rover) for information on how to become Hazmat trained and compliant if needed.
