This letter serves to acknowledge BMW of North America, LLC's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

BMW of North America, LLC (BMW) is recalling certain 2017-2018 M760Li xDrive vehicles. The affected vehicles have engine oil cooler lines that may loosen causing an oil leak in the engine compartment.

Consequence:

The leaking engine oil may get onto the front brake disks, lengthening the distance needed to stop the vehicle and increasing the risk of a crash.

Remedy:

BMW will notify owners, and dealers will inspect the engine oil cooler lines, replacing them as necessary, free of charge. The recall is expected to begin June 1, 2017. Owners may contact BMW customer service at 1-800-525-7417.

We have received BMW's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.


Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
