Chronology:

Graco was first notified an apparent testing failure on March 29, 2016. The apparent failure occurred in NHTSA testing conducted on January 29, 2015 at SGS as part of the agency's FY2015 compliance test program. Graco initiated an investigation and responded to the OVSC inquiry on May 10, 2016. Graco has been unable to replicate the SGS results. Graco's historical webbing test data and investigative testing did not result in any noncompliant webbing breaking strength values. On April 11, 2017, NHTSA informed Graco that additional testing of the FY2015 test samples resulted in one additional webbing breaking strength failure and one passing test. Graco's investigation to date has concluded that the testing failures are associated with a single batch of sewn webbing. After further discussion with NHTSA, and a meeting on May 3, 2017, Graco has decided to conduct a safety recall to remedy that batch of sewn webbing. Graco will continue its investigation to ensure that the scope of the recall is appropriate.
