## **Description of Noncompliance :**

-	General Motors has decided that certain 2016-2017 model year Chevrolet Suburban Heavy Duty (HD) vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) 111, "Rearview mirrors." These vehicles were assembled with a convex right-hand outside mirror. Because the weight rating for these heavy-duty vehicles exceeds 4,536 kg. (10,000 lbs.), FMVSS 111 requires non-convex, unit magnification (i.e., "flat") outside mirrors.
FMVSS 1 :	111 - Rearview mirrors
FMVSS 2 :	NR
Description of the Safety Risk :	If the driver of the vehicle is expecting a non-convex, unit magnification mirror, a convex right-hand outside mirror could potentially confuse the driver as to the distance between the vehicle and objects to the right-rear of the vehicle, increasing the risk of a crash.
Description of the Cause :	GM's specification for the affected mirror in these heavy-duty vehicles did not clearly designate flat glass. The supplier released the mirror with convex glass rather than flat glass.

#### **Chronology**:

On November 18, 2016, a line operator at General Motors' Arlington, TX assembly plant discovered a Chevrolet Suburban HD vehicle with an incorrectly labeled right-hand outside mirror. A report was submitted in GM's Speak Up for Safety program on November 22, 2016 and, on November 23, 2016, a stop work order was issued for the affected vehicles. GM opened an investigation into the issue on December 5, 2016. Upon review of the issue with GM's regulatory experts, the investigator determined that the mirrors had been released with convex glass instead of non-convex, unit magnification glass, as required by FMVSS 111 for these heavy-duty vehicles. The issue was reviewed by GM's Open Investigation Review board on December 19, 2016. On January 5, 2017, GM's Safety and Field Action Decision Authority decided to conduct a non-compliance recall.

#### **Description of Remedy :**

Description of Remedy Program :	Dealers will replace the affected mirror with a non-convex, unit magnification mirror that meets FMVSS 111 requirements. Also, GM will include a new page for the owner's manual with the customer notification letter. Pursuant to 49 C.F.R. § 573.13(d)(1), all covered vehicles are under warranty so reimbursement is not offered.
