On February 27, 2017, Forest River's Office of Corporate Compliance (OCC) received a report from Prime Time Manufacturing of a potential issue involving the Federal Placards. Forest River initiated an investigation including a review of the printed federal placards and the size of axles installed.

On March 3, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.
