• On February 28, FCA US Italy S.p.A. ("FCA Italy") determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

• On March 3, 2017, SW 13.02 was validated and released into production resolving the TPM Direct System.
