Description of the Safety Risk: Leaking fuel, in the presence of an ignition source, could lead to a fire causing

injury and/or damage to property.

Description of the Cause: External aging/oxidization reduces component strength over extended vehicle

life. Additionally, fuel components intrude into the fuel filter flange material under pressure from the inside and cause tension. Volkswagen assumes that the combination of both may - over time - eventually lead to formation of small cracks, allowing fuel to seep from the fuel filter flange.

February 2017 - NHTSA forwarded VOQs complaints to Volkswagen, referring to similar failures as reported under Audi recall 20W9. Volkswagen initiated a data review and identified a number of similar complaints. Parts were placed on submission, but in the short term no fuel filter flange replacements occurred. On March 1, 2017 the matter was presented in Volkswagen's Product Safety committee and a determination of defect was made.
