Description of the Noncompliance : The subject vehicles' Federal Placards indicate an incorrect Tire and Rim combination. The Federal Placard indicates ST205/75R15C Tires with 50 PSI and a rim designation of 15X5.5JJ, while the subject vehicles received ST205/75R14C Tires with 50 PSI and a rim designation of 14X5.5JJ.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : NR

Description of the Safety Risk : A user may overload the vehicle unintentionally, resulting in loss of control and may lead to a crash.

Description of the Cause : A data entry error resulted in the incorrect tire and rim specifications being printed onto the Federal Placard.

On March 8, 2017, Forest River's Office of Corporate Compliance (OCC) received a report from Cherokee of a potential issue involving the Federal Placards. Forest River initiated an investigation including a review of the printed federal placards and the size of tires and rims installed.

On March 10, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.

Description of Remedy :
