Description of the Defect : Some 2014 MY Fiat 500L vehicles may experience a diminished ability to accelerate or to maintain vehicle speed due to a software calibration issue in the Powertrain Control Module ("PCM"). This incorrect PCM software calibration could limit the engine to only idle speed and torque even if the accelerator pedal is fully depressed; when the pedal is fully released and then depressed again proper operation resumes.

Description of the Safety Risk : This safety defect may result in the diminished ability to accelerate or to maintain vehicle speed when expected. Diminished ability to accelerate or maintain vehicle speed may, in rare cases, result in a vehicle crash. This condition may occur without warning.
