- On March 22, 2017, the FCA US LLC ("FCA US") Vehicle Safety and Regulatory Compliance ("VSRC") organization opened an investigation as a result of communication from FCA Italy S.p.A. ("FCA Italy") engineering indicating a potential non-compliance of the sun visor labels.
- Between March 22, 2017 and April 11, 2017, the FCA US VSRC reviewed the 2014-2017 MY VF driver and passenger airbags, engineering releases, driver and passenger sun visor labels, the dashboard (hangtag) label, and Owner's Manuals, and User Guide editions to identify a potential non-compliance to FMVSS 208.
- On April 18, 2017, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary non-compliance recall of the affected vehicles.

#### **Description of Remedy:**

Description of Remedy Program: FCA US will conduct a Voluntary Non-compliance Recall on all affected

vehicles to correct the sun visor labels, the dashboard (hangtag) label, and

Owner's Manual and User Guide information.
