Description of the Defect : The outside frame floor structure of the trailer can fail.

FMVSS 1 : NR

Description of the Safety Risk : Multiple failure of the outriggers could result in structural instability of the trailer.

Description of the Cause : A revision in floor deck design has resulted in additional load on the floor frame structure and the outriggers failing.

Identification of Any Warning that can Occur : The living portion of the trailer could start to sag. Inspection of the sagging portion can be done to identify broken welds on the outriggers.

On 4-20-2017 a new Quicksilver TH 7X20 arrived back to the factory after being towed to various locations for display. The unit was inspected and the defect was found. A decision was made to issue a voluntary recall to remedy all units in the population.

Description of Remedy :

Description of Remedy Program : The remedy will be to reinforce the outrigger frame structure and add additional outriggers if required.

How Remedy Component Differs from Recalled Component : The increased reinforcement of the outriggers can be seen visually.

Identify How/When Recall Condition was Corrected in Production : Currently, no trailers of this model are scheduled for production. When production resumes, the floor frame will have the remedy incorporated.

Description of Recall Schedule : Livin Lite will notify the dealers and owners of the recreational vehicles by letter. A final copy of the owner letter will be provided to NHTSA, along with the dealer repair procedures.
