Description of the Noncompliance : The tire and rim combinations reflected on the Federal Placard do not reflect the tire and rim combination installed on the vehicle and in some cases the GAWR and GVWR are incorrectly listed.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 567 - Certification

Description of the Safety Risk : Based on the information provided on the placard, the potential exists to overinflate the tire or overload the vehicle(s), which may affect the operator's ability to control the vehicle.

Description of the Cause : Due to an error in the data system the tire and rim combination data tables did not match and incorrect information was printed on the placards.

On April 21, 2017, Forest River's Office of Corporate Compliance (OCC) received a report from Forest River Corporate Data Entry of a potential issue involving the Federal Placards. Forest River initiated an investigation including a review of the printed federal placards and the size of tires and rims installed.

On April 26, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
