**Description of the Noncompliance :** The subject vehicles' Federal Placards indicate an incorrect the Rear Tire Pressure (PSI) as 50 PSI, while the subject vehicles' Tires require 80 PSI.

**FMVSS 1 :** 110 - Tire selection and rims

**FMVSS 2 :** NR

**Description of the Safety Risk :** A user may under-inflate the tire which could potentially lead to pre-mature tire failure and increase the risk of a crash.

**Description of the Cause :** A data entry error resulted in the incorrect tire pressure specification being printed onto the Federal Placard for the rear axle only.

## Chronology :

On May 3, 2017, Forest River's Office of Corporate Compliance (OCC) received a report from XLR ToyHaulers of a potential issue involving the Federal Placards. Forest River initiated an investigation including a review of the printed federal placards and the tire requirement for PSI.

On May 5, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.

On July 10, 2017, OCC discovered that only 52 vehicles are US Production. The remaining three vehicle are Canadian production.

## Description of Remedy :

Description of Remedy Program : Forest River will provide all required parts and labor, free of charge to both Owners and Dealers.
