Description of the Noncompliance : On certain model Vista Cruiser/ Vintage, Cruiser travel trailers (RV's) manufactured by Gulf Stream Coach, Inc. (GulfStream) the originally installed Federal Identification Label may not contain the correct tire size information. The label incorrectly indicates ST215/75R 14 C rated tire(s), when it should be a ST205/65R 14 D rated tire(s).

FMVSS 1 : 567 - Certification

FMVSS 2 : NR

Description of the Safety Risk : The Federal Identification Label correctly states the [GVWR] Gross Vehicle Weight Rating. Trailers loaded in accordance to that weight rating do not pose a safety risk. However, relying on the tire size information from an inaccurate label may result in purchasing incorrect replacement tires.

Description of the Cause : Incorrect axle weight rating information applied to certain configuration numbers used to print Federal Weight Labels
