Description of the Defect : The mirrors located on the back of the closet door can loose and become unattached. The adhesive used to secure the mirrors to the back of the closet door was not compatible with the final safety backing on the mirror.

Chronology :

On June 15, 2017 a consumer provided Pleasure Way photographic evidence of a mirror that had become unattached from the back of the closet door. The mirror did not break or injure the consumer, but the mirror did fall to the floor once becoming unattached from the closet door. The Pleasure Way Research and Development department started an investigation following the receipt of the consumer's evidence. A second email complaint was received by Pleasure Way on June 16, 2017 showing evidence of another mirror becoming unattached from the closet door; from a different consumer. Both vehicles have the production dates within November 2016. On June 19, 2017 it was determined that a safety recall would be conducted. This recall will include all 2017 Pleasure Way Lexor TS vehicles produced from September 1, 2016 to June 19, 2017.

Description of Remedy :

Description of Remedy Program : Pleasure Way will inspect the mirrors and attach six mechanical mirror clips.

How Remedy Component Differs from Recalled Component : Mechanical mirror clips securing the mirror to the back of the closet door, rather than adhesive.
