Description of the Defect : Furnace flue was not installed to allow proper venting of the furnace combustion system to the outside of the trailer living quarter.

Customer contacted Lakota Trailers on Monday June 26, 2017 regarding furnace not being vented. Photo was provided to confirm. Searched dealers website photos and identified two more trailers without furnace flues.

Description of Remedy :

Description of Remedy Program : Each dealer has been contacted to stop any retail sales. Retail customers are being called. half of all retail customers have been contacted by phone with all confirming flues installed. We will continue to call every retail customer. We will recall all trailers even ones we know the flue is installed. We will ask dealers to inspect and confirm flue is installed and if not installed will send flues and instructions on how to install. We will reimburse for installation.

How Remedy Component Differs from Recalled Component : There is no component recalled. The trailer may lack a furnace flue and will have installed. Trailers that do not have a flue installed will have a flue installed.

Identify How/When Recall Condition was Corrected in Production : All trailers in our possession were inspected on June 26, 2017 and three were immediately corrected.
