Descriptive Information :	The frame supplier, Lippert Components, Inc., indicated that based on manufacturing records it did not install the chassis stiffener from February 1, 2013 through July 31, 2013. Forest River, Inc. is expanding the scope thirty days prior to and after those dates in order to ensure all affected vehicles are captured. Vehicles outside this population include the frame stiffener.

Description of the Defect :	The frames do not have reinforcement stiffeners welded onto the exterior of the I-Beam to mitigate flex in the axle area.
FMVSS 1 :	NR
FMVSS 2 :	NR
Description of the Safety Risk :	Without the reinforcement stiffeners, under certain conditions excessive side load may be applied to the axle area. In some cases the axle hangers or the lower flange of the I–Beam may twist or break. This may lead to misaligned axles and/or overloading of the suspension which could affect vehicle handling and increase the risk of a crash.
Description of the Cause :	The frames where built by the supplier without the vertical stiffener welded to the web, bottom and top flange of the I-Beam.
Identification of Any Warning that can Occur :	An operator may notice cracked or torn steel on the bottom of the frame in the axle area.

Forest River's Office of Corporate Compliance ("OCC") received a single report of an axle hanger failure in June, 2017 from its manufacturing plant involving a MY2013 vehicle.

OCC was notified of three additional failures in July, 2017, also involving MY 2013 vehicles a review of company data for a five year period indicated that Forest River had only received the same 4 claims to date. The claims were spread widely across VIN numbers, and had different reported component failures including damage to the outrigger, axle hanger and cracked frames

In early September, 2017 the manufacturing plant received 2 additional complaints. Forest River also requested its supplier, Lippert Components, Inc. (LCI), to review its records and warranty data. LCI provided Forest River a copy of its warranty findings and also indicated that it had had not been installing the reinforcement stiffener since the start of production in February 2013. LCI indicated it began installing the stiffener on the frame beginning on July 31, 2013, which corresponds to a design change.

On September 29, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.
