Description of the Noncompliance : The subject vehicles' Federal Placards indicate an incorrect tire pressure. The Federal Placard indicates the tire pressure to be 35 PSI. The correct tire pressure is 50 PSI.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 567 - Certification

Description of the Safety Risk : An under-inflated tire may lead to reduced handling of the vehicle which may lead to loss of control and potentially a crash.

Description of the Cause : A data entry error occurred when entering the parameters of the affected tire's PSI.

Chronology :

On September 22, 2017, Forest River's Cargo Division found a single vehicle in their possession with the incorrect PSI listed on the Federal Placard. The manufacturing plant reported the issue to Forest River's Office of Corporate Compliance (OCC), Forest River initiated a research item, including a review of the printed federal placards and the size of tires, PSI and rims installed. Upon further investigation, on September 26, 2017, the manufacturing plant advised OCC that a data entry error occurred when the tire was initially entered into the vehicle parameters.

On September 29, 2017, Forest River's Corporate Committee decided to conduct a recall to address this issue.

Description of Remedy :

Description of Remedy Program : Forest River will provide new Federal Placards, free of charge to both Owners and Dealers.

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
