Chronology :

Winnebago was notified on November 6, 2017 by a dealer that at delivery check in, the battery cable and hydraulic line were damaged due to contact with the drive shaft. On November 7, 2017 in house units were inspected and additional units were found to have the same defect. On November 7, 2017 Rework Campaign 636 was issued and all units in house were placed on hold and began research on the population of affected units. On November 17, 2017 a meeting of the Safety Committee was held and the determination was made to conduct a Recall Campaign.

Description of Remedy :

Description of Remedy Program : Dealer will visually inspect all battery cables and hydraulic lines to ensure they are properly secured, and free from damage. If found to be not properly secured, they will route and secure all battery cables and hydraulic lines, and replace any found to be damaged. Winnebago authorized service center will submit a Warranty Service Claim to Winnebago.

How Remedy Component Differs from Recalled Component : NR
