Description of the Noncompliance : The Federal Placard incorrectly states the tire to be ST215/75R15/D, whereas the tires on the vehicle are ST205/75R15/D. The PSI, rim designation and load rating are not affected.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 567 - Certification

Description of the Safety Risk : If tires of the incorrect tire size are installed, this may lead to reduced handling of the vehicle which may lead to loss of control, increasing the risk of a crash.

Description of the Cause : A data entry error occurred when entering the parameters of the affected tire's size.
