July 2017: Conformance of Production tests showed abnormalities in head curtain airbag deployment in the foremost position. All previous tests had shown 100% compliance with FMVSS 226.

August 2017: The matter was presented to the Audi Product Safety Committee. A validation program, additional tests and evaluations were ordered.

August 2017 - November 2017: Intensive additional tests were conducted, determining the contributing factors/causes and consequences with respect to passenger safety.

December 13, 2017: The Audi Product Safety Committee made the determination of defect due to non-compliance with FMVSS 226.

### **Description of Remedy:**

the upper part of the A-pillar, will be removed.
