On July 25, 2017 repairs can begin for vehicles affected by Safety Recall 20Z4. Please refer to the campaign circular posted to Elsa and ServiceNet for additional information.

IMPORTANT REMINDER ON VEHICLES AFFECTED BY SAFETY & COMPLIANCE RECALLS

New Vehicles in Dealer Inventory: It is a violation of Federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

<u>Pre-Owned Vehicles in Dealer Inventory:</u> Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

Dealers must ensure that every affected inventory vehicle has this campaign completed <u>before delivery</u> to consumers.

PROBLEM DESCRIPTION	On certain vehicles, the fuel pump flange may develop fine cracks or fissures, which could result in a fuel leak. Leaking fuel, in the presence of an ignition source, could lead to a fire causing injury and/or damage to property.
CORRECTIVE ACTION	If cracks, leaks, and/or yellow discoloration are present, the fuel pump flange will be replaced and a protective film installed onto the fuel pump flange. If no cracks, leaks, and/or yellow discoloration are present, a protective film will be installed onto the fuel pump flange.

PRECAUTIONS	If a fuel smell is detected in the vehicle, customers are advised to immediately contact the nearest authorized Volkswagen dealer in order to have the vehicle inspected.
