Affected vehicles will be flagged in VMI as "OPEN" and Work Instructions will be available in Star TekInfo. Once the repair is complete, the vehicle may be sold or leased.

Loaner and demonstrator vehicles may continue to be driven, but must not be retailed until repaired.

Additionally, given this notice, it is a violation of Federal Law for car rental companies to rent MY16-17 C-Class vehicles covered by this notification until the vehicle has been repaired.

Daimler AG ('DAG'), the manufacturer of Mercedes-Benz vehicles, has become aware that in certain C-Class (205 platform) vehicles, the contacts inside the power steering electric motor might not have been properly welded. If the pins completely lose electrical contact, the electric power steering assist will deactivate. This could increase the risk of a crash. An authorized Mercedes-Benz dealer, will replace the electric power steering rack on the affected vehicles.
