Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2017-2018 Dutchmen Voltage Fifth Wheels. As a result, Keystone RV is conducting a safety recall.

***Reason for  
this recall***

It has been decided the vehicles subject to this recall campaign may not have the fuel line clamped to the generator properly. If the fuel line disconnects, it increases the risk of a fuel leak leading to an increased risk of fire, personal injury and property damage. The vehicles included in the recall are:
