Daimler AG ('DAG'), the manufacturer of Mercedes-Benz Metris vehicles, has determined that on certain MY17 447 Metris vans, the electrical contacts in the control module of the electric power steering rack may not have been properly welded. If the pins completely lose contact, the electric power steering assist may deactivate, increasing the risk of a crash.


