

IMPORTANT T56 SAFETY RECALL ANNOUNCEMENT OCCUPANT RESTRAINT CONTROLLER

At your service (2012 - 2013 CHRYSLER 200/DODGE AVENGER & 2012 JEEP LIBERTY)

RECALL OVERVIEW

Mopar would like to inform you of important information regarding the T56 Safety Recall that impacts certain 2012 – 2013 Chrysler 200/Dodge Avengers as well as 2012 Jeep Liberty vehicles. These vehicles may experience an illuminated Airbag Warning Lamp due to a failure in the Occupant Restraint Controller (ORC). This may result in the inability of the vehicle to deploy active headrests during certain rear-end crashes. This may increase the risk of injury to the front seat occupants during rear-end crashes.

NOTE: 2012-2013 model year Chrysler 200 / Dodge Avenger vehicles can be repaired under this campaign or Safety Recall S61. The remedied ORC for S61 contains the remedy for this campaign. Vehicles that have had Safety Recall S61 completed will be removed from this campaign and these customers will not be notified of safety recall T56.

VIP & CLAIM HANDLING: Chrysler 200 and Dodge Avenger Vehicles that have NOT had S61 completed will show <u>both</u> T56 and S61 open in VIP. <u>Only one</u> ORC will need replacement therefore an inspection LOP is provided to clear the recall that is a duplicate. Please utilize the below LOPs on whichever Safety Recall claim does not get closed with the ORC replacement LOP. ORC replacement should <u>not</u> occur twice. The inspection LOP should be placed on the same claim in a separate condition. The inspection LOP pays .2 hrs.

- S61 Inspection LOP: 08 S6 11 81
- T56 Inspection LOP: 08 T5 61 81
