Compliance Recall Notice 17C04 / NHTSA Recall 17V-168 Aviso de Revisión de Cumplimiento 17C04

2017 Mustang Your Vehicle Identification Number (VIN):

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that your vehicle, with the VIN shown above, fails to conform to Federal Motor Vehicle Safety Standard (FMVSS) 206 S4.1.1.4, Door Locks & Door Retention Components – Inertial Load Requirement.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

What is the issue? On your vehicle, a spring inside the left-hand interior door handle may be

installed incorrectly. If the spring becomes unseated, the door could unlatch

during a side impact, increasing the risk of injury in a crash.

What will Ford and your dealer do? Ford Motor Company has authorized your dealer to inspect the left-hand interior door handle and if necessary, to repair your vehicle free of charge

(parts and labor).

How long will it take? The time needed for this repair is less than one-half day. However, due to

service scheduling requirements, your dealer may need your vehicle for a longer period of time. In addition, your vehicle will require an inspection to

determine if parts need to be ordered.

What should you do? Please call your dealer without delay and request a service date for Recall

17C04. Provide the dealer with your VIN, which is printed near your name

at the beginning of this letter.

Ford Motor Company wants you to have this recall completed on your vehicle. The vehicle owner is responsible for making arrangements to have

the work completed.

What should you do? (continued)

Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

Your vehicle may be equipped with a diagnostic feature called the Vehicle Health Report, which can inform you about all available recalls, as well as other key vehicle health information. Please see

What if you no longer own this vehicle?

If you no longer own this vehicle, and have an address for the current owner, please forward this letter to the new owner.

You received this notice because government regulations require that notification be sent to the last known owner of record. Our records are based primarily on state registration and title data, which indicate that you are the current owner.
